NOTICE FOR THE COLLECTION OF EXPRESSIONS OF INTEREST FOR THE SUPPLY OF 1 B737-400 CARGO AIRCRAFT IN WET LEASE

PREAMBLE

The purpose of this notice is to collect expressions of interest for the initiation of a competitive tender for the supply of 1 B737 - 400 cargo aircraft or, in the event of unavailability, of 1 B737 - 300F aircraft or equivalent in WET LEASE

Whereas:

the supply covered by this contract, falling within the scope of the carriage of express courier parcels, for which Poste Italiane has obtained exemption pursuant to Article 30 of Directive 2004/17 (currently Article 34 of Directive 2014/25 and Article 8 of Legislative Decree no. 50/2016 and subsequent amendments and additions) and the related provision of the European Commission of 30 April 2008 (DPCM - Department of Community Policies of 25 June 2008 published in the Official Gazette no. 214 of 12 September 2008), is not subject to the rules set out in Legislative Decree no. 50/2016 and is not subject to the rules set out in Legislative Decree no. 50/2016 and in the Official Gazette no. 214 of 12 September 2008).

The legislative references contained in this notice and in the documents available on the portal www.posteprocurement.it, relating to this tender, are to be understood as referring only to the legislative and/or regulatory provisions expressly referred to as the occasion arises.

PROPOSING PARTIES

Those interested in expressing their interest must have the following certifications:

- Copy of EU Operating Licence;
- Copy of the certificate of registration of the aircraft involved;
- Copy of the certificate of airworthiness (CofA) and Airworthiness Review Certificate (ARC) of the aircraft involved;
- Copy of the noise certificate of the aircraft involved;
- Copy of the air operator certificate (AOC);
- Copy of the operations specifications;
- Copy of aircraft radio license of concerned aircraft;
- Copy of third-party liability insurance certificate(s) of concerned aircraft;
- Part 145 Approval Certificate (if available);

THE MANNER IN WHICH EXPRESSIONS OF INTEREST ARE PRESENTED

Interested parties, in order to view all the documentation, must apply for authorisation to use the portal www.posteprocurement.it, as better specified in Annex A to this notice - Arrangements for the application for authorisation to use the portal - and if they intend to present their expression of interest, they must fill out the form of


expression of interest published therein, always send it through the portal www.posteprocurement.it, signed by the legal representative, together with a copy of the identity document valid for the subscriber and the other required documentation, no later than **13:00** on **09/10/2019**.

Applications sent after the above deadline will not be taken into consideration.

The expression of interest and submission of the offer shall not in any way constitute a right and/or claim for the economic operator to enter into the agreement, nor shall it entail any reimbursement of any costs incurred for the submission of the expression of interest, with Poste Italiane reserving any greater freedom to refrain from further awarding the service.

Attachment A - Arrangements for the application for authorisation to use the portal

How to apply for authorisation to use the portal www.posteprocurement.it

The company concerned, in order to apply for authorisation to use the portal www.posteprocurement.it, must:

- a) fill out the "Online portal registration form" (accessible by clicking on the "register" link located on the home page of the portal, at the bottom left).

During the procedure of filling in the online form, it will be possible to choose an access key (User ID), while the password to access the portal will be sent by e-mail only after the electronic transmission of the aforementioned form.

The User ID and password will be activated only after sending (according to the procedures in paragraph c)) and the positive verification of the "Portal Registration Contract";

- b) download, complete and sign the "Portal Registration Contract";
- c) send the "Portal Registration Contract", duly completed and digitally signed, to posteprocurement@bravosolution.it

The authorisation procedure will be considered completed when the support service activates the User ID and Password.

A company that has already been authorised to use the portal should not request a new licence, without prejudice to the right to contact the support service (at the addresses above) to communicate any changes in the registration data or in case of loss of access codes (User ID and Password).

The Company is required not to disclose to any third parties the access key through which it will be identified by the Italian Post Office, or the password.

Please note that the portal authorisation and support service are completely free of charge.

In the event of failure to reply after 24 hours from the sending of the requested documentation, it is necessary to contact the support service at the addresses indicated above.
